

A report from the independent Mental Health Taskforce to the NHS in England February 2016

- 20 000 people involved
- Chair Paul Farmer, MIND

3 Key Themes:

- Access To High Quality 7 Day Services (Urgent & Emergency Care; Liaison MH)
- ☐ Integration of Physical & MH Care in Hospital & PC (IAPT LTCs & MUS; Perinatal; Premature mortality)
- Prevention (CYP; employment support; CJ System; PH; Suicide prevention)

Plus

■ Need to 'Hard wire the system' – stigma; timely access; capture & flow of data

Couple of Key Messages

- ☐ CYP funding is additional
- CCGs should be increasing MH spending above baseline
- ☐ 'Invest to save'

The Five Year Forward View for Mental Health Mental Health Taskforce Implementation Plan

- HEE Mandate IAPT Deliverable by 2020/21:
- (i) Provide for a further expansion of access to integrated psychological therapies for adults with anxiety and depression to reach 25% of need, with a focus on those with long-term physical health conditions and people who are out of work.
- (ii) Trial new models for delivering psychological therapies and building a robust invest-to-save case for integrating psychological therapies into primary care and secondary acute specialist teams to support the wider expansion programme and to increase access for adults with psychosis, bipolar disorder and personality disorder.

What's Coming?

2016/17

- New LTCs module being developed for PWPs and HIT
- Identification of early adopter sites for 2016
 - Upskill existing staff
 - Back fill
 - Trial new delivery models

2017/18

 Continue full roll out year one further funding followed by invest to save model up to 2021
